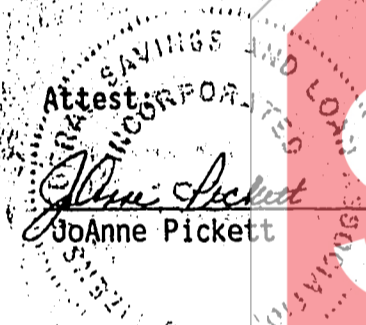
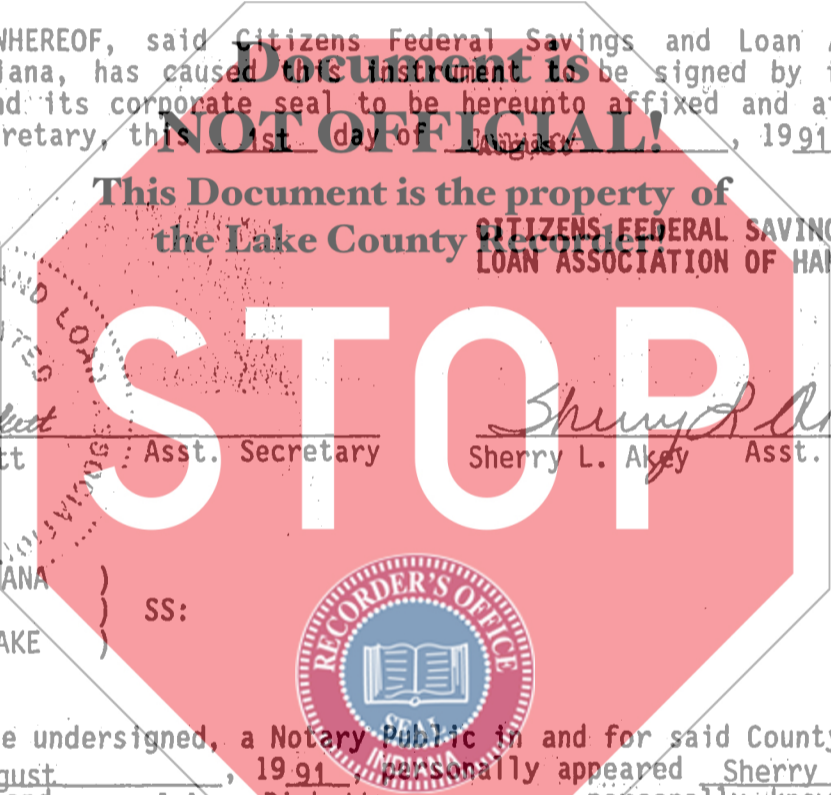
SATISFACTION OF MORTGAGE
