SATISFACTION OF MORTGAGE

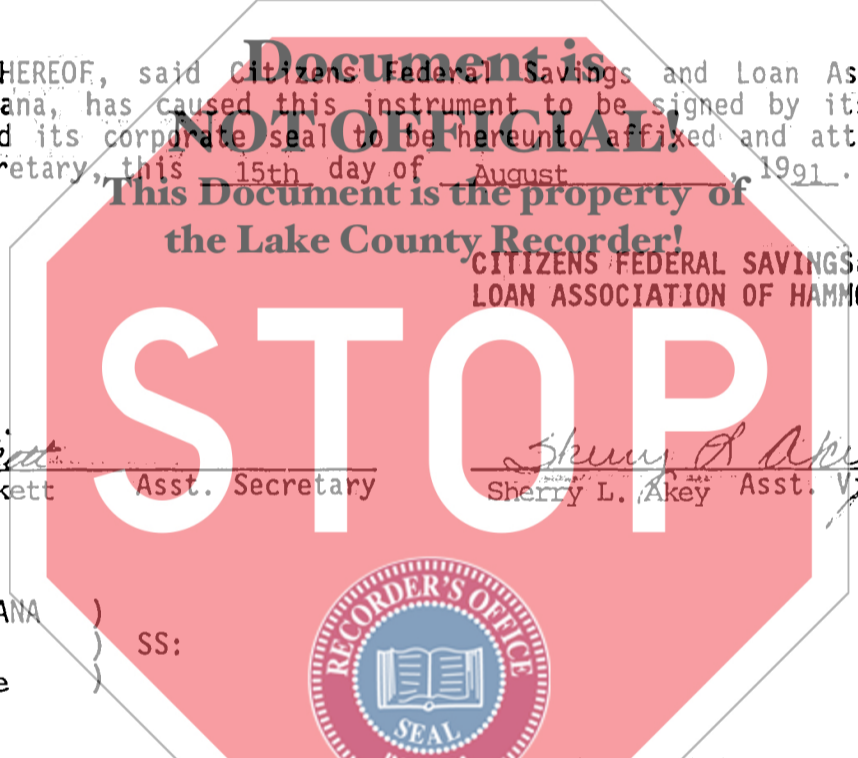
