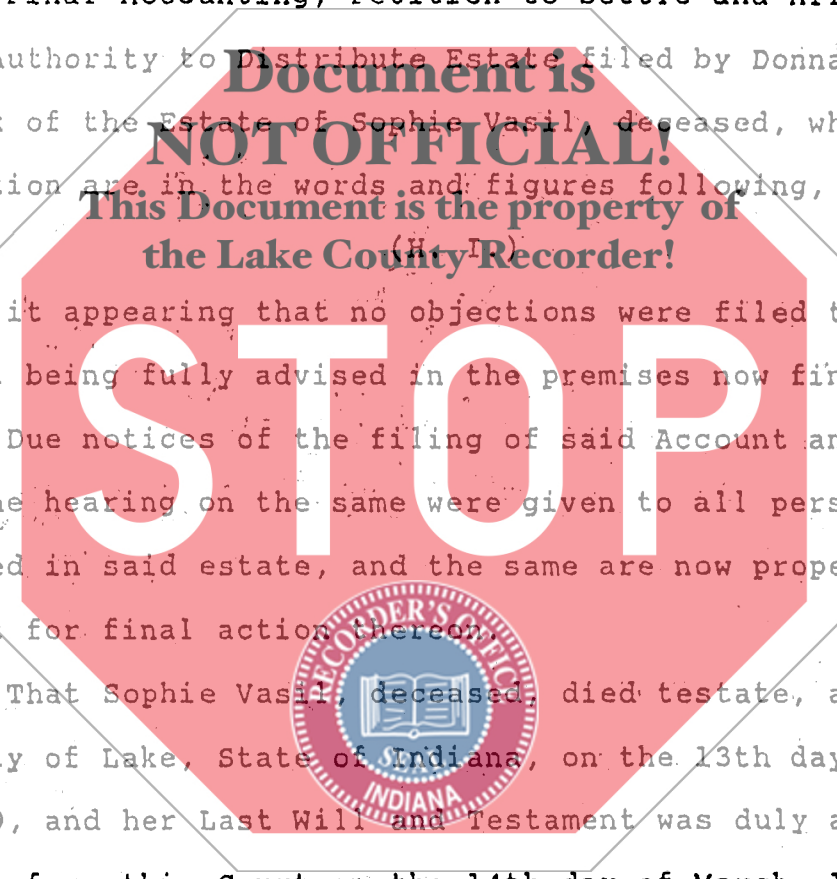

And it appearing that no objections were filed thereto and
the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said Account and Petition
and of the hearing on the same were given to all persons
interested in said estate, and the same are now properly before
the Court for final action thereon.

2. That Sophie Vasil, deceased, died testate, a resident of
the County of Lake, State of Indiana, on the 13th day of Septem-
ber, 1989, and her Last Will and Testament was duly admitted to
probate before this Court on the 14th day of March, 1990, and
this Court appointed the said Donna Pavel as Executrix of the
Last Will and Testament of the decedent, and said Executrix was
issued Letters Testamentary on the 14th day of March, 1990 to her
and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said Account and Petition are true and that said Executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under decedent's Last Will and Testament:

Donna Pavel, 820 E. 37th Avenue, Gary, Indiana, 46409

6. That the decedent owned a certain piece of real estate at the time of her death located at 820 E. 37th Avenue, Gary, Lake County, Indiana, legally described as follows:

Lots 32, 33, and the West 9 feet of Lot 34, in Block 20, in South Gary Subdivision in the City of Gary as per plat thereof recorded in Plat Book 7, page 13 in the Office of the Recorder of Lake County, Indiana.

and that by clause III(a) of decedent's Last Will and Testament said real estate was devised to Donna Pavel and title to said described real estate now vests in the said respective devisee pursuant to the terms of said Will.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

1. That Final Report and Account of said Executrix is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Executrix' hands for distribution has been made pursuant to the distribution set forth in the Final Accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. Said Executrix having made distribution of all assets and property, said distribution is hereby approved and confirmed.

4. Said Executrix is ordered to record with the Recorder of Lake County, Indiana a copy of this Order to transfer title to the above-described real estate to Donna Pavel pursuant to the terms of the decedent's Last Will and Testament.

5. That Donna Pavel, as Executrix of the Estate of Sophie Vasil, is hereby discharged from any further liability or responsibility and said estate is hereby closed.

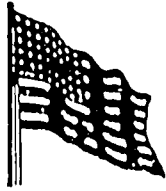

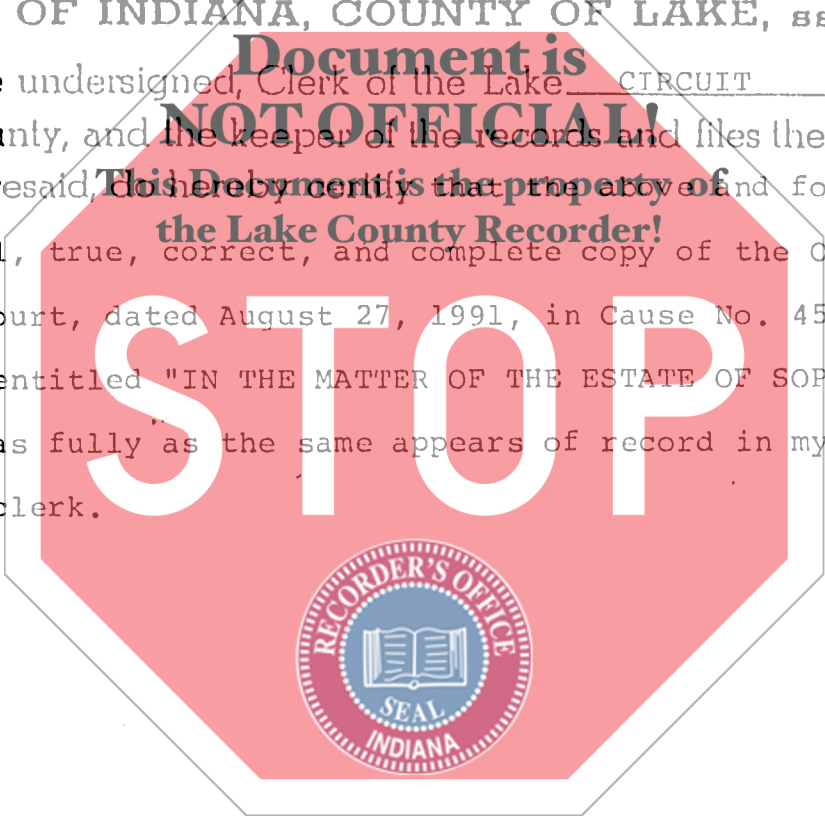
