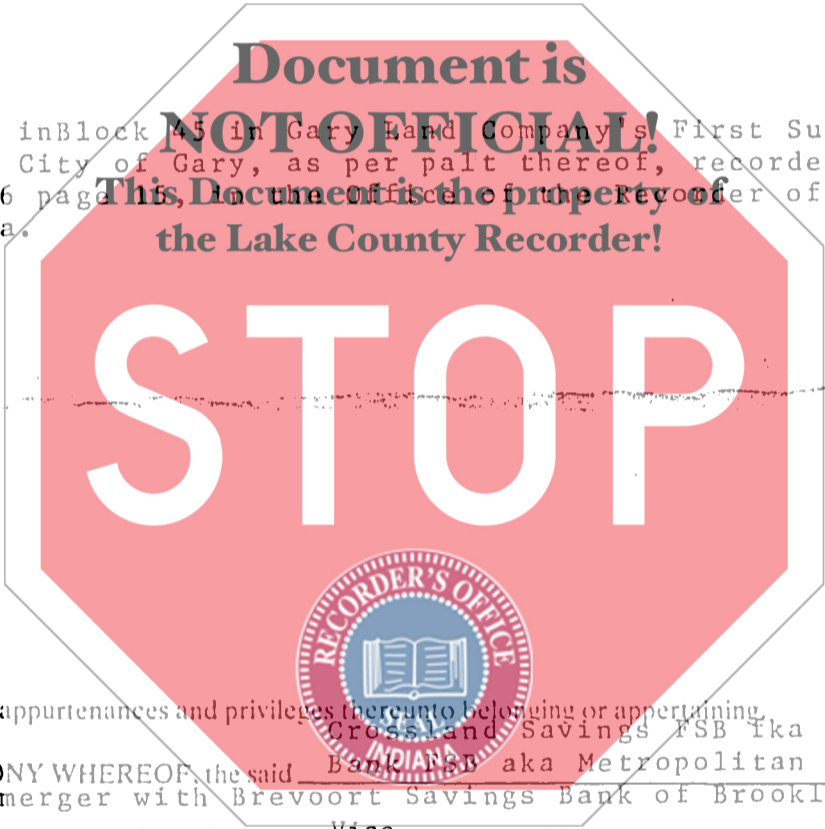


KNOW ALL MEN BY THESE PRESENTS, That the Crossland Savings FSB
