Releases and quit claims to LINDA K. JONES, a Single Woman,

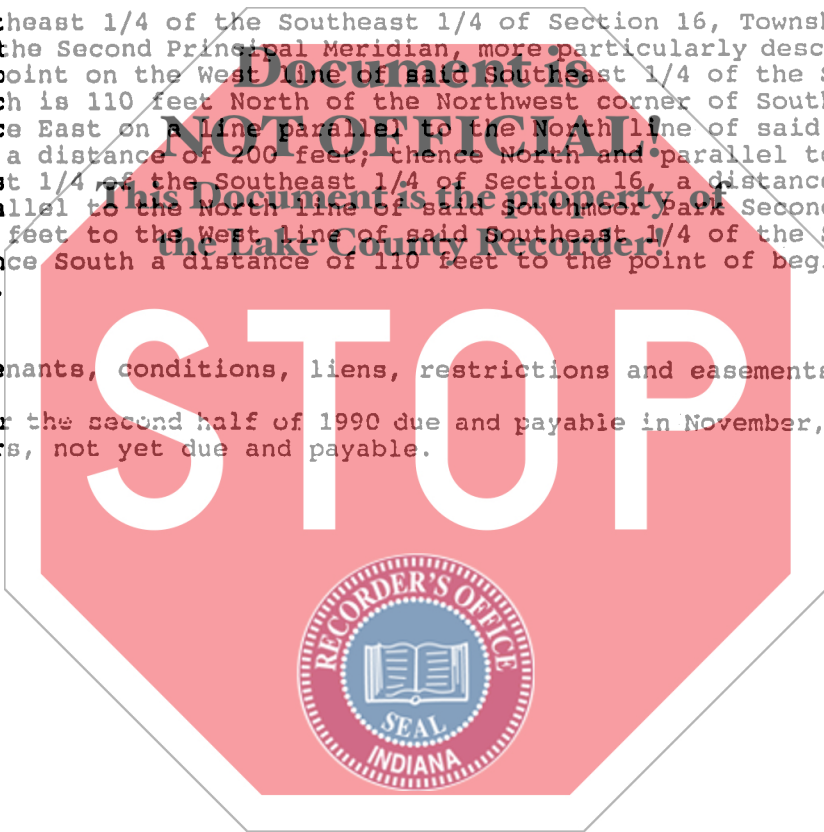
