# WARRANTY DEED

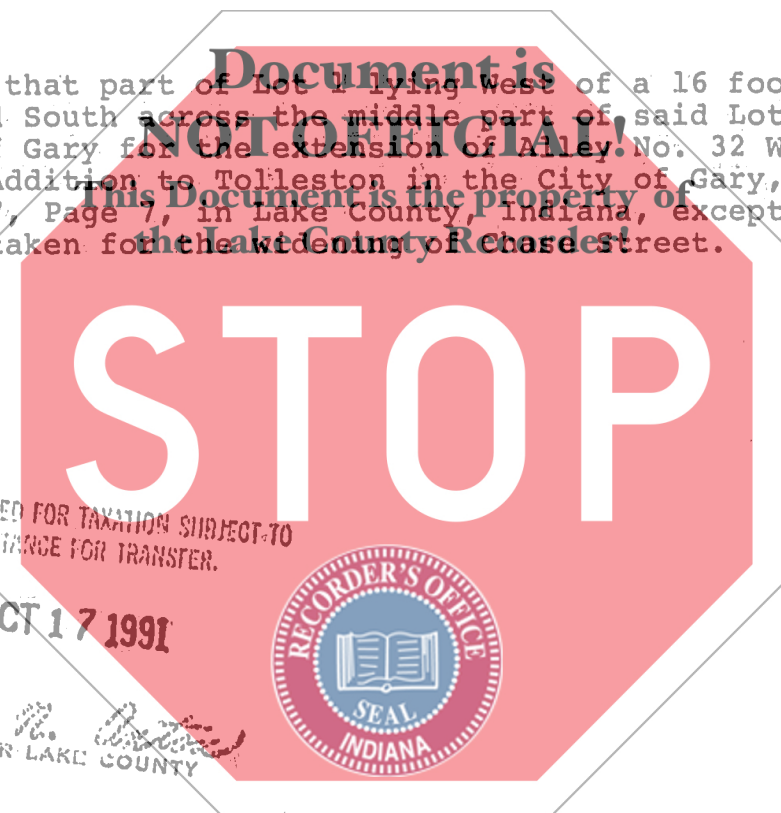
This indenture witnesseth that DR. WILLIAM H. MOTT AND ELAINE MOTT
