Property Insurance. Borrower shall keep the improvements existing or hereafter erected on the Property insured against loss by fire, nazards included within the term "extended co-tage" and any other hazards, including floods or flooding, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires.
