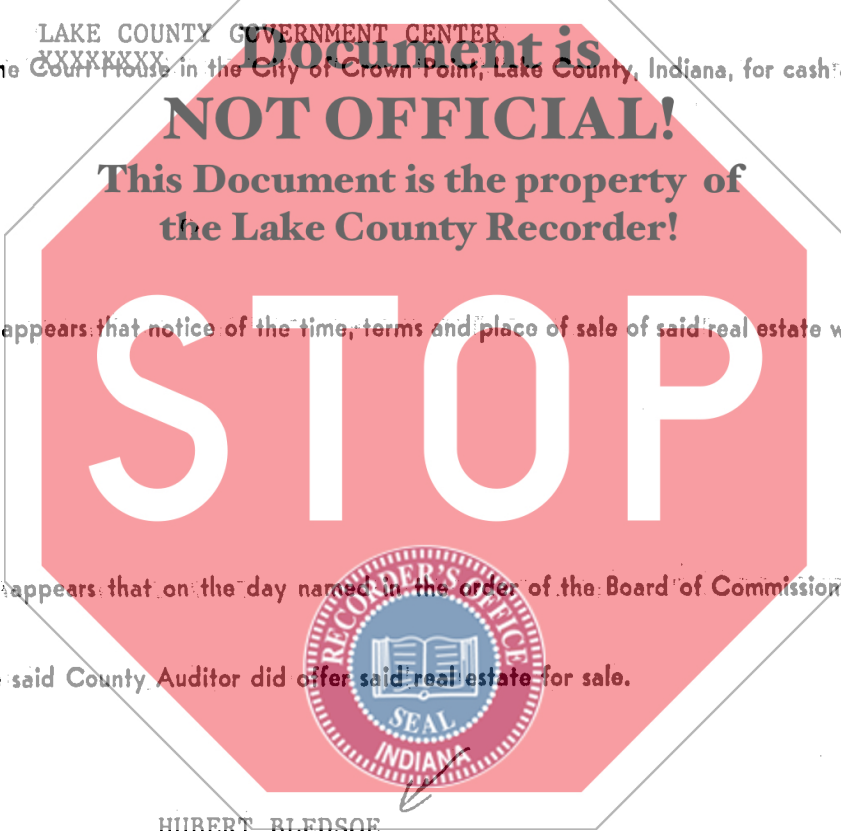

AND, WHEREAS, HUBERT BLEDSOE did then and there bid the sum of ONE THOUSAND ONE HUNDRED SEVENTY FIVE dollars and NO/100 cents, and that the County Auditor did then and there accept said bid.
