ASSUMPTION AGREEMENT

This agreement, made this <u>12TH</u> day of <u>November, 1991</u> by Peoples Bank, A / Federal Savings Bank of Munster, Indiana a United States Corporation, hereinafter called the Bank and <u>Charles J. Johnson</u>, hereinafter the Purchaser and <u>Charles Kluko and Betty Kluko, Husband and Wife</u>, hereinafter the Mortgagor.

The parties hereto mutually stipulate as follows:

1. Charles Kluko and Betty Kluko, Husband and Wife are indebted to Bank under a certain promissory note dated September 4, 1986 in the principal amount of Twenty Thousand and 00/100 (\$20,000.00) and said note being secured by a mortgage dated even therewith and recorded on September 10, 1986, as Document No. 874162 in the Office of the Recorder of Lake County, Indiana on the following described property:

- 2. The Mortgagor has sold and conveyed to Purchaser all of the real property described in the said mortgage, and both Mortgagor and Purchaser have requested Mortgagee to enter into this Agreement.
- 3. In consideration of the sale described above, Charles J. Johnson hereby assumes the indebtedness of Charles Kluko and Betty Kluko, Husband and Wife to Peoples Bank, A Federal Savings Bank.
- 4. Peoples Bank, A rederal Savings Bank agrees to the assumption of the indebtedness owed under said note and hereby releases Charles Kluko and Betty Kluko, Husband Wife of any further lieby lify.
- 5. Charles J. Johnson promises and agrees to be bound by each and every term of the aforementioned note and mortgage. It is expressly understood and agreed that said mortgage and note shall remain in full force and effect in all respects. The covenants of said mortgage and note are expressly incorporated by reference herein.
- 6. Charles J. Johnson further agrees that the principal balance due on the note as of November 12, 1991 is Fighteen Thousand Seven Three Dollars and 64/100 (\$18.073.64 with interest at a rate Ten and 125/100 (10.125%) per annum. Principal and interest shall be paid by Charles J. Johnson in consecutive monthly installments of one Hundred Ninety Four and 69/100 (\$194.69), beginning on January 1, 1992 and shall continue each month thereafter until the entire indeptedness due is paid in full except that any remaining indebtedness if not sooner paid, shall be due and payable on January 31, 2007.
