This obligation may be cancelled by said Surety by giving thirty (30) days notice in writing of its intention so to do to said Oblige; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Oblige.

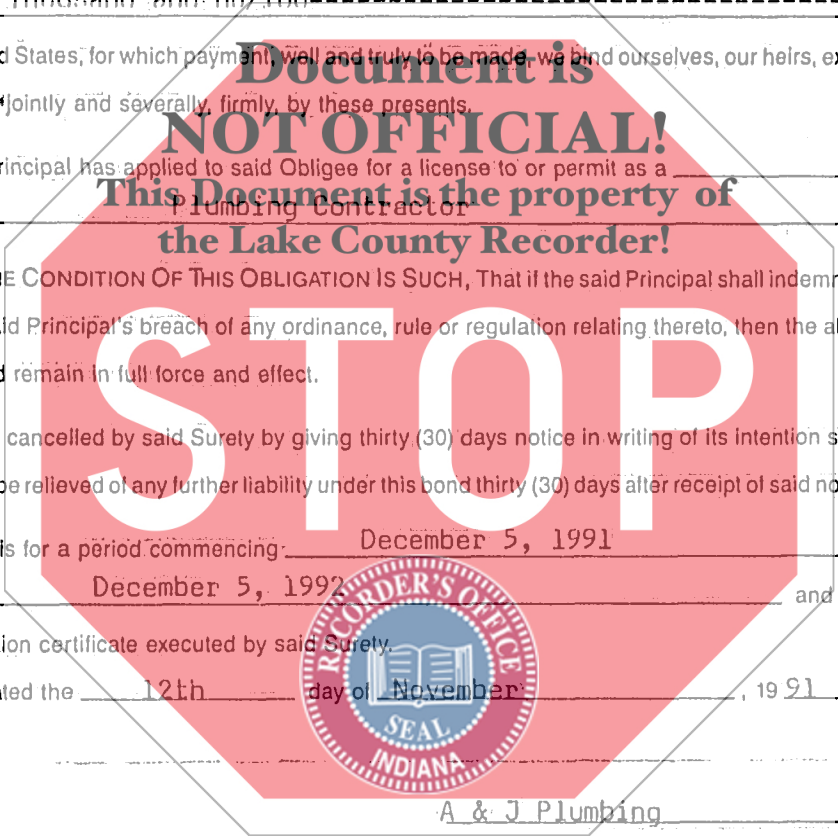
The term of this bond is for a period commencing December 5, 1991 and terminating December 5, 1992 and may be continued from year to year by continuation certificate executed by said Surety.

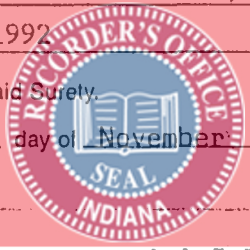

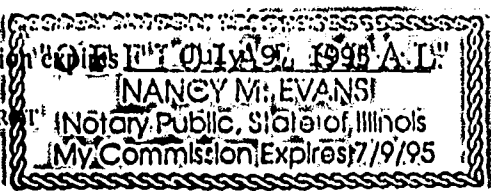
