This mortgage shall serve as notice to any and all persons that Mortgagors and BANK ONE have entered into a certain Equity Money Service Agreement dated December 20., 19. 91., establishing a line of credit for Mortgagors in the amount of \$10.000.00. Subject only to Mortgagors' billing error rights; the indebtedness secured by this mortgage from time to time shall be determined by BANK ONE's books and records.
