

- 1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall apromptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late, charges due under the Note.
- 2: Funds for Taxes and Insurance. Subjects to applicable law or to a written waiver by Lender, Borrower shall paying Lender on the day monthly payments are due under the Note, until the Note is paid in full, a sum ("Funds") for: (a) yearly taxes and assessments—which may attain priority over this Security Instrument as a lien on the Property; (b) yearly leasehold payments or ground rents on the Property, if any; (c) yearly hazard or property insurance premiums; (d) yearly floods insurance premiums, if any; (e) yearly mortgage insurance premiums, if any; and (f) any sums payable by Borrower too Lender, in accordance with the provisions of paragraph 8, in lieu of the payment of mortgage insurance premiums. 6. Occupancy, Preservation, Maintenance and Protection of the Property; Borrower's Loan Application Leaseholds. 
