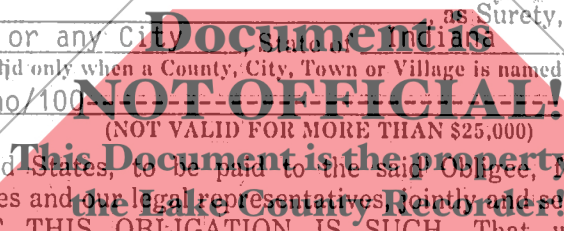

lawful money of the United States, to be paid to the said Obligees, for which payment well and truly to be made, we bind ourselves and our legal representatives jointly and severally.

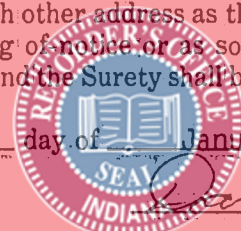
THE CONDITION OF THIS OBLIGATION IS SUCH, That whereas, the Principal has been licensed HVAC Contractor

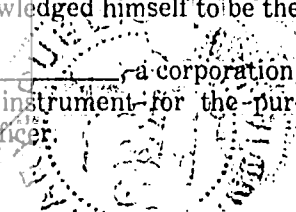
