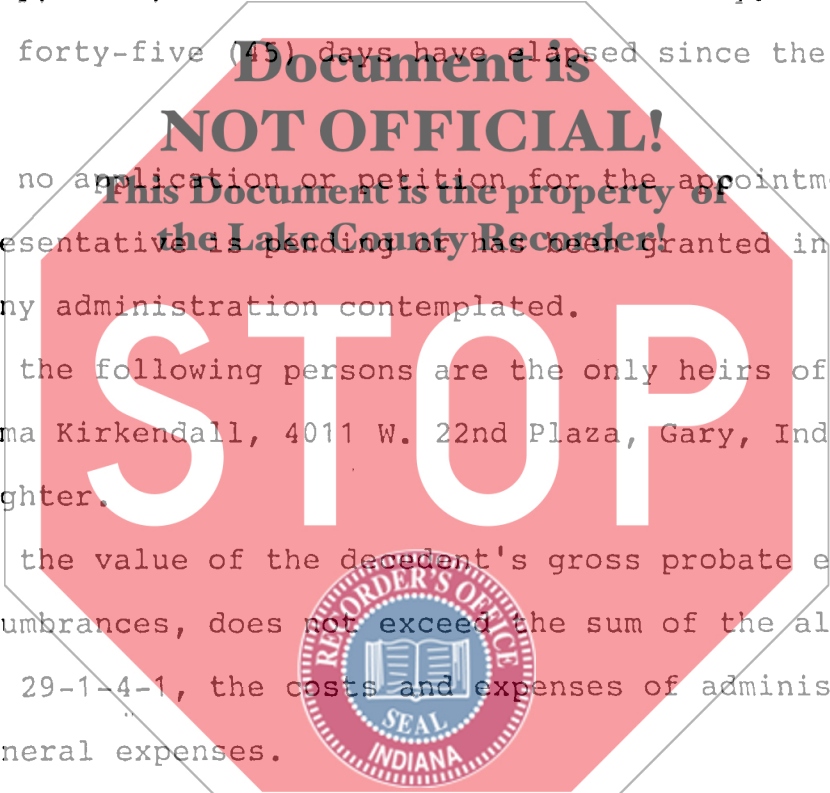
5. That the value of the decedent's gross probate estate, less

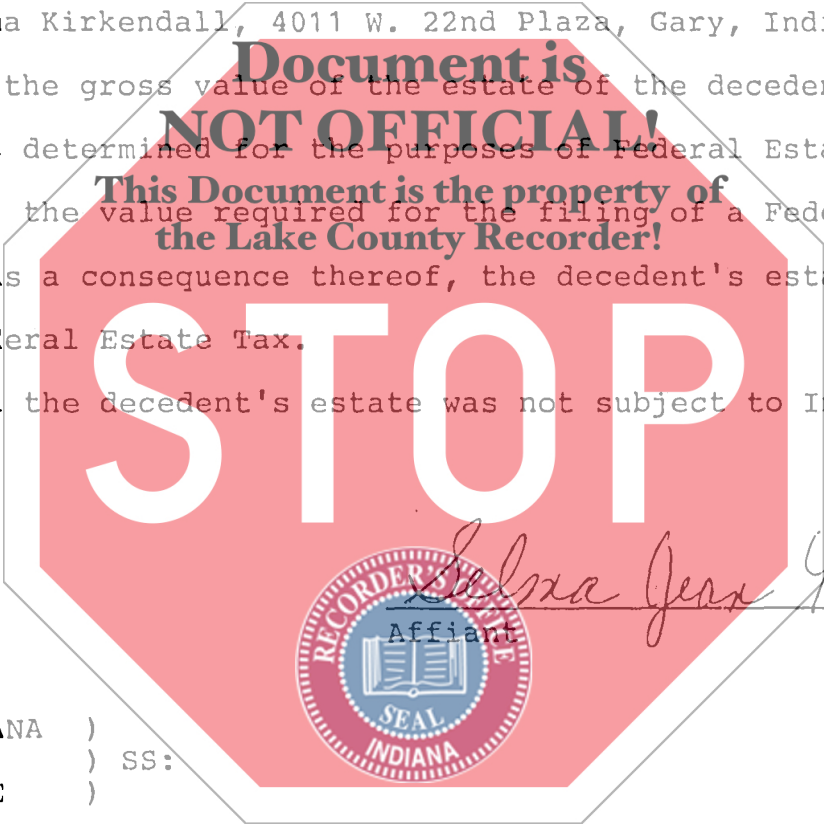
