POWER OF ATTORNEY

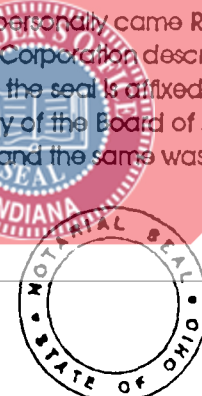
