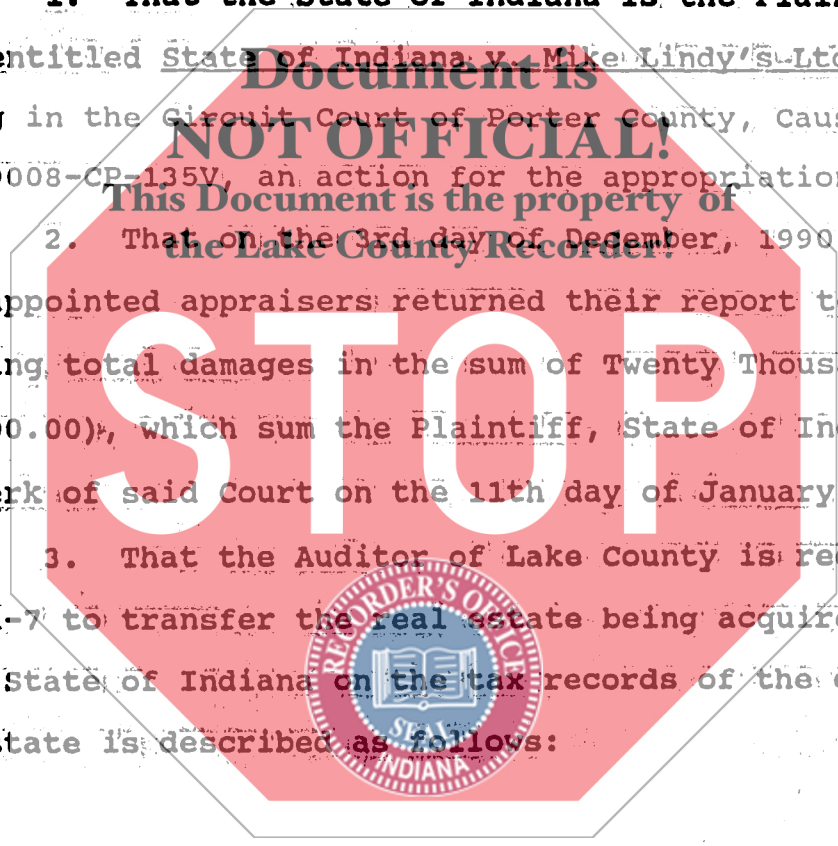
CERTIFICATION OF PAYMENT OF COURT-APPOINTED APPRAISERS' AWARD AND REQUEST FOR TRANSFER

Linley E. Pearson, Attorney General of Indiana, by Jeffrey L. Simnick, Deputy Attorney General, for and on behalf of the State of Indiana, certifies:

1. That the State of Indiana is the Plaintiff in the cause entitled State of Indiana v. Mike Lindy's Ltd., et al., pending in the Circuit Court of Porter County, Cause No. 64C10-9008-CP-135V, an action for the appropriation of real estate.

2. That on the 3rd day of December, 1990, court-appointed appraisers returned their report to the Court, assessing total damages in the sum of Twenty Thousand Dollars (\$20,000.00), which sum the Plaintiff, State of Indiana, paid to the clerk of said Court on the 11th day of January, 1991.
