

SATISFACTION OF MORTGAGE

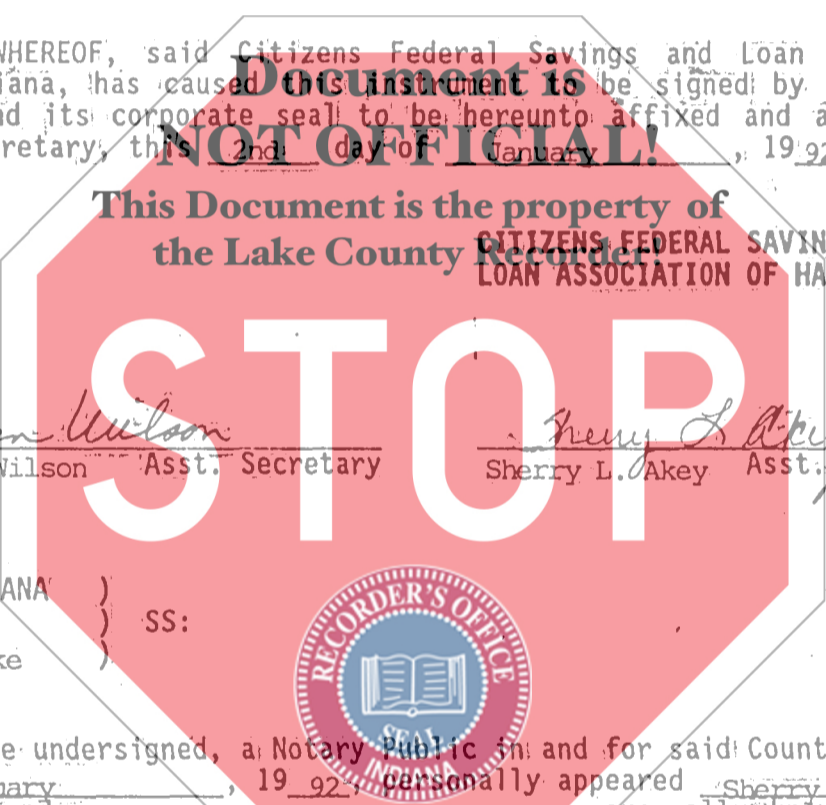

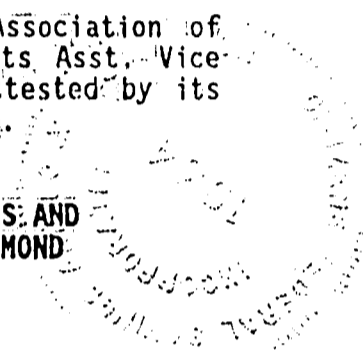
