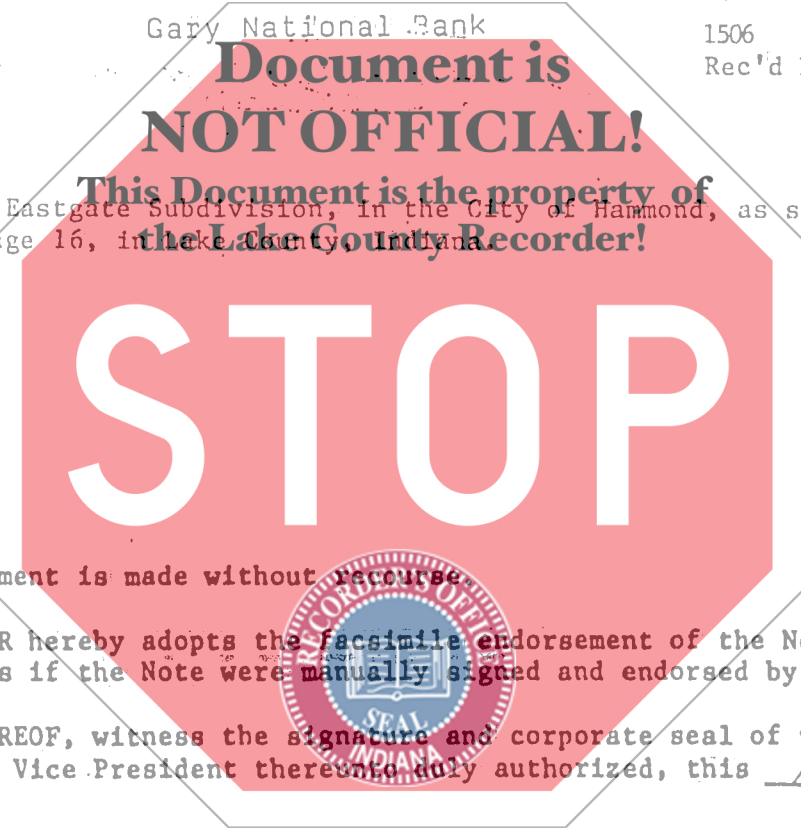
ASSIGNMENT OF MORTGAGE (Indiana)
