# Loan Modification Agreement

WHEREAS LIBERTY SAVINGS ASSOCIATION, F.A.

loaned Richard E. Olszewski & Susan Olszewski  
(Husband & Wife)

the sum of: Sixty Three Thousand & NO/100-----Dollars

(\$ 63,000.00 ), as evidenced by a note and mortgage executed and delivered on July 14, 1986 which mortgage is duly recorded in the public records in the Jurisdiction where the mortgaged property is located, which note and mortgage are hereby incorporated herein as a part of this instrument, and DOCUMENT # 864611

WHEREAS, the undersigned, owner of said premises, has found it necessary and does hereby request a modification of the terms of said loan for the following reasons:\*

Said principal and interest shall be payable at such offices as the note holder may designate in 234 consecutive monthly instalments of \$484.37 on the first day of each month beginning February 1, 1992 and until the first day of each succeeding month thereafter until the principal and interest are fully paid, except that the final installments if not sooner paid, shall be due and payable on the first day of August, 2011.

AND WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unpaid balance of said indebtedness is:

Fifty Eight Thousand Three Hundred Seventy & 89/100-----Dollars (\$ 58,370.89 )

all of which the undersigned promises to pay with interest at 7.75 % per annum until paid, and that the

same shall be payable Four Hundred Eighty-Four & 37/100-----Dollars (\$ 484.37 )

per month beginning on the 1st day of February 19 92, to be applied first to interest,

and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.

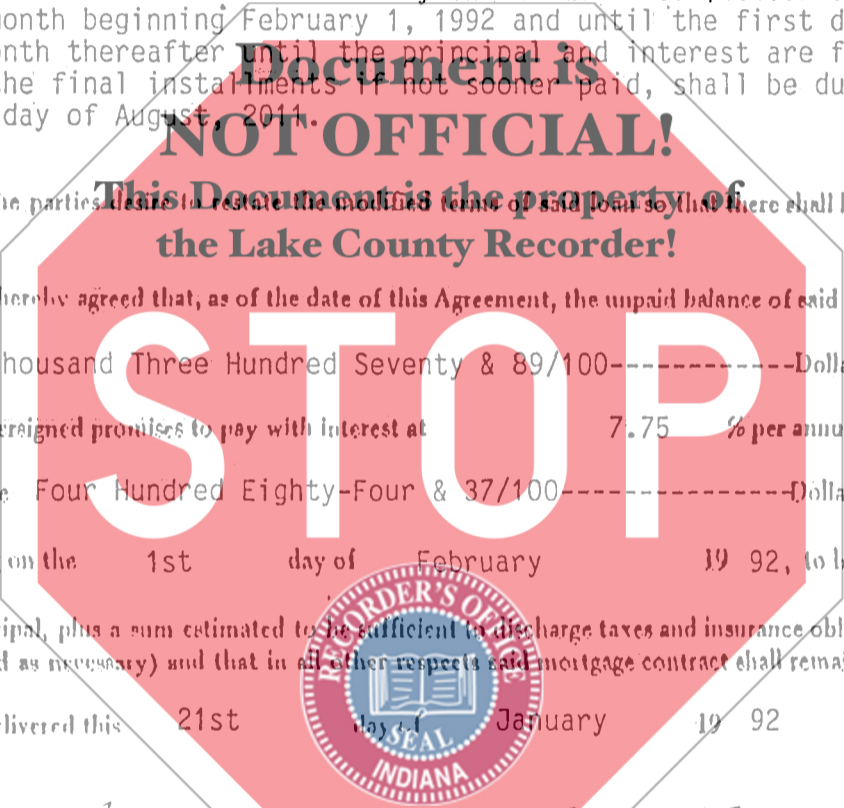
