*UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. A. INTEREST RATE

The Note provides for an initial rate of 8.25%. With a ceiling rate of 14.00% and a floor rate of 8.00%. The Note provides for changes in the interest rate, as follows:

The interest rate I pay will change on the date of change in the Index. Each date on which my interest rate could change is called a "Change Date."

BE THE INDEX

Beginning with the circle harge Date, my interest will be based on an Index. The Prime Rate is Peoples Bank, A Federal Savings Bank posted Prime Rate. The Prime Rate is Peoples Bank's base rate of interest for short term (less than one year) loans to substantial and responsible Borrowers and is the rate set by the Lender, from time to time, and is used to establish the actual rate charged those Borrowers whose loans bear interest at a rate related to or tied to the Prime Rate.

C. CALCULATION OF CHANGES

On each Change Date, the Note Holder will calculate my new interest rate by adding 150 basis points (*1.50%) to the Index. At no time will the rate exceed 14.00% nor fall below 8.00%.

D. EFFECTIVE DATE OF CHANGES

My new interest rate will become effective on each Change Date.

B. NOTICE OF CHANGES

The Note Holder will deliver or mail to me a notice of any changes in my interest rate.
