RELEASE OF EASEMENT FOR ELECTRICAL LINES

THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for Electrical Lines executed by Sisters of Mercy of Hammond, Indiana, Incorporated dated April 3, 1941, recorded June 24, 1941, in Book 333, Page 118, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to Sisters of Mercy of Hammond, Indiana and to ITS successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land containing 0.0918 acres, more or less, in the Northwest Quarter (NW 1/4) of Section 13, Township 35 North, Range 10 West of the Second Principal Meridian, being ten (10) feet wide lying five (5) feet each side of a center line, said center line produced, said center line being described as follows:

Being on the West property line of Gettler Street in the town of Dyer and 25 feet North of the center line of Stech Street extended, thence North 87 degrees 22 minutes West, a distance of 400 feet. part of Key # 114-184-1
