RELEASE OF EASEMENT FOR ELECTRICAL LINES

THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for Electrical Lines executed by Sisters of Mercy of Hammond, Indiana, Incorporated dated January 19, 19 42, recorded January 30, 19 42, in Book 338, Page 273, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to Sisters of Mercy of Hammond, IN and to ITS successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land containing 0.077 of an acre, more or less, in the Northwest Quarter (NW 1/4) of Section 13, Township 35 North, Range 10 West of the Second Principal Meridian, being ten (10) feet wide, lying five (5) feet wide on each side of a center line and said center line produced, said center line being described as follows:

Beginning at a point which is North 87 degrees 22 minutes West a distance of 227 feet from the intersection of the West line of Gettler Street and a line parallel to, and twenty-five (25) feet North of, the center line of Stech Street extended Westerly in the town of Dyer; thence North 35 degrees 49 minutes 30 seconds West a distance of 336 feet to a point.
