DESCRIPTION OF REAL ESTATE LOCATED IN LAKE COUNTY  
INDIANA MORTGAGED BY A CERTAIN MORTGAGE FROM BROAD-  
WAY LUMBER & SUPPLY CORP. TO BANK OF INDIANA,  
NATIONAL ASSOCIATION AND DATED THE DAY OF

Parcel 1: That tract of land in Lake County, Indiana described as follows: Being all of that part of Charles A. Blank's Subdivision of the East Half of Block 2, of the Town of Miller, being a subdivision of the South Half of Section 6, Township 36 North, Range 7 West of the 2nd P.M. in Lake County, Indiana, lying East of the East line and the East line extended to the South right of way line of the Baltimore and Ohio Railway of Lot numbered 1 in Block numbered 5 of the said subdivision, and North of the center line extended of the alley running East and West in said Block 5, the tract herein conveyed being all that part of Block A in said subdivision North of the tract owned by William Carnduff; also all that part of Charles A. Blank's Subdivision of the East Half of Block 2, of the Town of Miller, being a subdivision of the South Half of Section 6, Township 36 North, Range 7 West of the 2nd P.M. in Lake County, Indiana, lying east of the East line and the East line extended of Lot 11 in Block 5 of the said subdivision, and South of the center line extended of the alley running East and West in said Block 5.

Parcel 2: Lots 1, 2 and 3 Block 4, Chas. A. Blank's Subdivision at Miller, in the City of Gary, as shown in Plat Book 6, page 5 in Lake County, Indiana

Parcel 3: That piece or parcel of land situated in Section ten (10), Township 36 North, Range 8 West of the 2nd P.M., more particularly described as follows: Commencing at a point on the north line of Eleventh Avenue extended eastwardly from the east line of the street called Broadway, as said streets are now laid out and used in the City of Gary, which said point on said north line of said Eleventh Avenue extended is one hundred fifty-five (155) feet east of and from said east line of Broadway; thence east on a line parallel to the north line of said Section 10 to the point of intersection of said east and west parallel line with the south line of the right of way of the Michigan Central Railway Company, which said point of intersection is hereby designated as the point of beginning; thence return west on said line last above drawn a distance of seven hundred forty-seven and seventy-eight hundredths (747.78) feet; thence north parallel to said line of Broadway a distance of one hundred ninety-four and eight hundredths (194.08) feet to the said south line of said right of way of the Michigan Central Railway Company; thence southeasterly upon said south line of said right of way to the said point of beginning, in Lake County, Indiana

Parcel 4: Part of the Northwest Quarter of Section 10, Township 36 North, Range West of the 2nd P.M. in the City of Gary, Lake County, Indiana, more particularly described as follows: Commencing at a point on the North line of 11th Avenue and 1232.02 feet East of the West line of said Section 10; thence North 03 degrees 59 minutes 20 seconds East a distance of 15.37 feet more or less to the Southerly right of way line of the Michigan Central Railroad and the point of beginning of the herein described parcel; thence continuing North 03 degrees 58 minutes 20 seconds East 27.32 feet; thence North 74 degrees 05 minutes 38 seconds West 100.01 feet; thence North 79 degrees 04 minutes 53 seconds West 25.07 feet; thence North 75 degrees 14 minutes 59 seconds West 43.00 feet; thence North 82 degrees 51 minutes 05 seconds West 160.56 feet; thence South 15 degrees 09 minutes 00 seconds West 3.95 feet, more or less, to the Southerly right of way line of said Michigan Central Railroad; thence Southeasterly along the Southerly line of said Railroad to the point of beginning.
