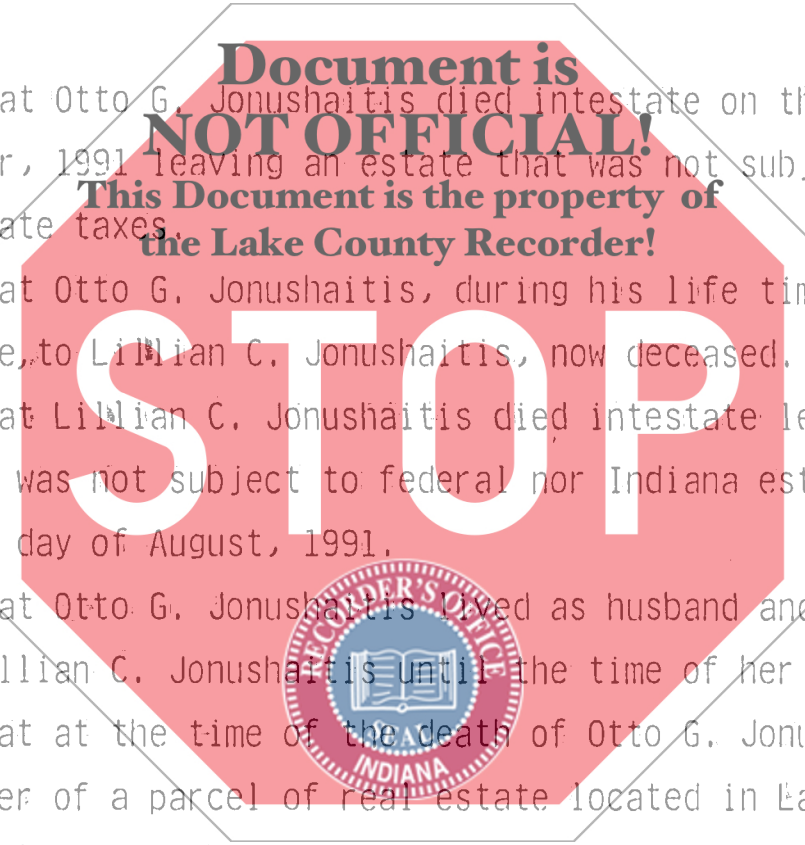
7. That Otto G. Jonushaitis died leaving as his sole heir at law, his daughter Laura Otto.
