This mortgage shall serve as notice to any and all persons that Mortgagors and BANK DNE have entered into a certain Equity Money Service Agreement dated January 31 19 92 establishing a line of credit for Mortgagors in the amount of \$ 10,000,00 (the "Equity Money Service Agreement") which may be inspected at the offices of BANK DNE by any interested persons. The terms and provisions of the Equity Money Service Agreement, as the same may be amended from time to time, are incorporated in this mortgage by reference with the same force and effect as though fully set forth herein. The fulfillment and performance of the terms and conditions of the the Equity Money Service Agreement are additionally societed by this mortgage. The Equity Money Service Agreement obligates BANK ONE to make future advances to Mortgagors under definite conditions.

MORTGAGORS agree that:

- a. This mortgage is given to secure the payment of all indebtedness evidenced by or incurred pursuant to the Equity Money Service Agreement now or in the future, beginning with the date of this mortgage and ending with the close of business on <u>January 31, 2002</u>, 19
- b. Interest on each advance shall accrue from the date made until repayment, at the rates agreed upon in the Equity Money Service Agreement.
- c. All advances shall be evidenced by the Equity Money Service Agreement and shall be payable without relief from valuation or appraisement laws, and with costs of collection to the extent permitted by law. Subject only to Mortgagors' billing error rights, the indebtedness secured by this mortgage from time to time shall be determined by BANK ONE's books and records.
- d. The word "advances" as used in this mortgage shall mean loans of money. In the event of any conflicts or inconsistencies between the terms of this mortgage and the terms of the Equity Money Service Agreement, the terms of the Equity Money Service Agreement shall control.

Mortgagors jointly and severally covenant and agree with BANK ONE that:

- 1. Mortgagors will pay all indebtedness secured by this mortgage when due, as provided in the Equity Money Service Agreement and in this mortgage, with attorneys' fees, and without relief from valuation or appraisance that
- 2. The lien of this mortgage is prior and superior to all other liens and encumbrances against the Mortgaged Premises, except that mortgage described as follows: From Borrowers to Waterfield Mortgage dated January 12, 1990 and recorded January 17, 1990 and the "Prior Mortgage". Mortgagers agree to pay all sums when due and to fully abide by all terms and conditions of the Prior Mortgage.

 3. Mortgagors will not further encumber not permit any mechanics or materialmen's liens to attach to the Mortgaged Premises. 2. The lien of this mortgage is prior and super the Mortgaged Premises, except that certain
