COVENANTS

- 1: Payments, Lagree to make all payments on the segmed debt when due. Unless we agree otherwise, any payments you receive from the or for my benefit will be applied first to any amounts Lowe you on the secured debt exclusive of interest or principal, or cond, to interest and then to principal. If partial prepayment of the secured debt occurs for any reason, it will not reduce or excuse any subsequently scheduled payment until the secured debt is paid in full.
- 2. Claims against Title. I will pay all taxes, assessments, fiens, encommunicis, lease playments, ground cents, and other charges relating to the property when due. You may require me to provide to you capies of all notices that such amounts are due and the accepts evidencing my payments. I will defend title to the property against any claims that would impair the lien of this mortgage. You may require me to assign any rights, claims or defenses which I may have against parties who supply labor or materials to improve or maintain the property.
- 3. Insurance. I will keep the property insured under terms acceptable to your at my expense and for your benefit. This insurance will include a standard mortgage clause in your tayor. You will be named as loss payee or as the insured on any such insurince policy. Any insurance proceeds may be applied, within your discretion, to either the restoration or repair of the damaged property or to the secured debt.
