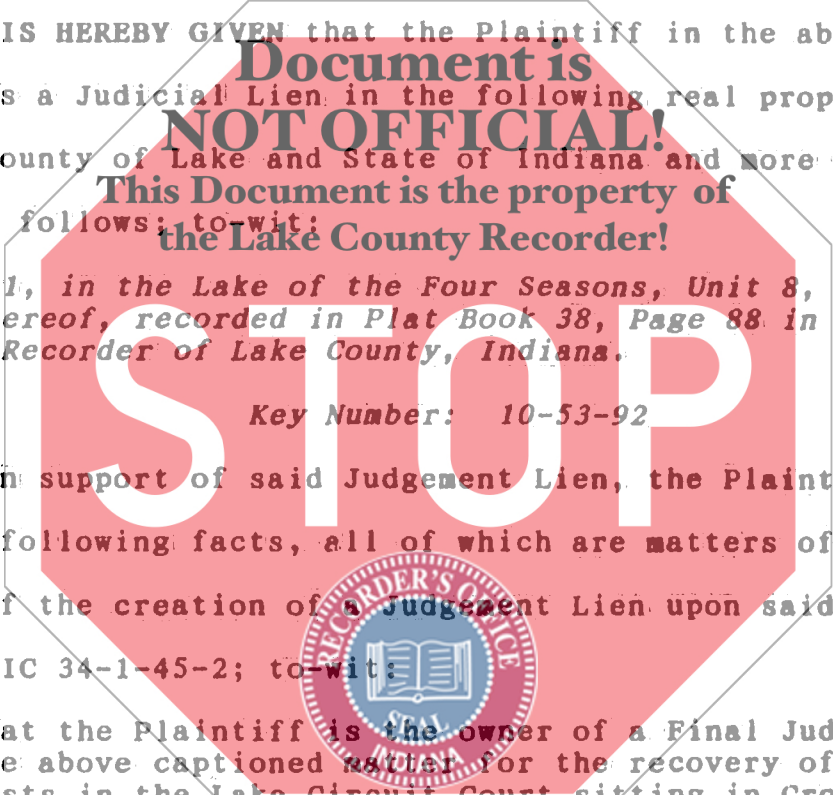

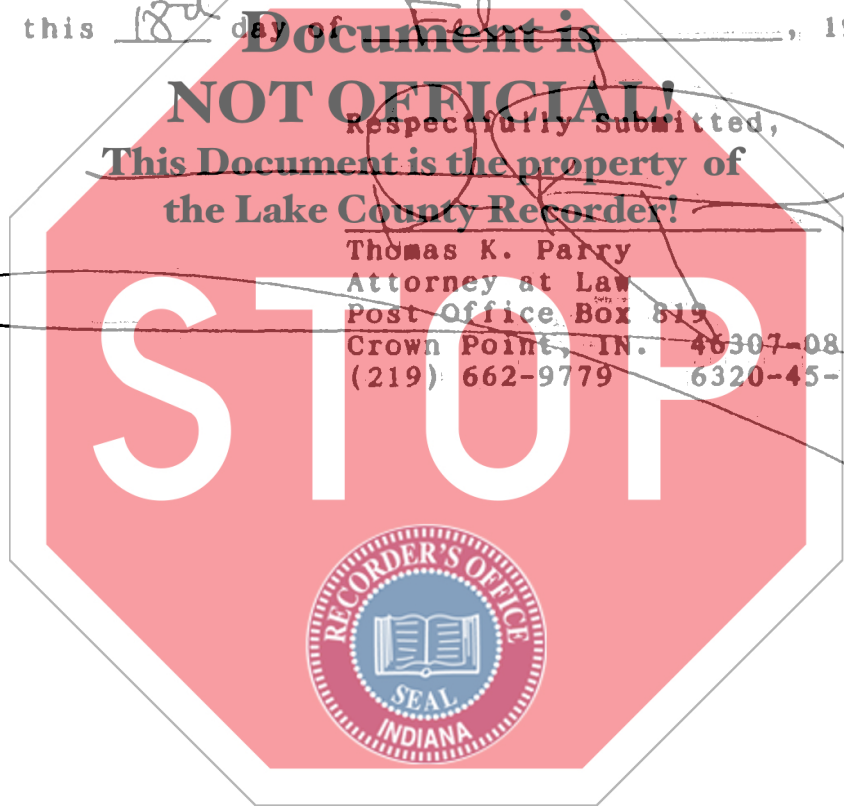
That, in support of said Judgement Lien, the Plaintiff herein alleges the following facts, all of which are matters of Public Record in support of the creation of a Judgement Lien upon said property pursuant to IC 34-1-45-2; to-wit:

- 1.) That the Plaintiff is the owner of a Final Judgement in the above captioned matter for the recovery of money or costs in the Lake Circuit Court sitting in Crown Point, Indiana against said Defendant; said Judgement was entered on 08/11/89.
- 2.) That, at the time said Judgement was entered against said Defendant, said Defendant held the above stated property as a Tenant in Common pursuant to the Orders of the Lake Superior Court in Cause Number 45D04-8807-DR-00418 entered on the 2nd day of August, 1989.
- 3.) That subsequent and some time thereafter and on or about the 3rd day of April, 1990, said Defendant became the Owner in Fee Simple of said property pursuant to a Quit Claim Deed recorded as Document Number: 094740.
