WHEREAS, the undersigned, owner of said premises, has found it necessary and does hereby request a modification of the terms of said loan for the following reasons:*

Said principal and interest shall be payable at such offices as the note holder may designate in 168 consecutive monthly installments of \$158.25 on the first day of February, 1992 and until the first day of each succeeding month thereafter until the principal and interest are fully paid on or before October 2005.

AND WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unpaid balance of said indebtedness is

Fifteen Thousand Nine Hundred Sixty Three and -----66/100 Dollars (\$ 15,963.66)

all of which the undersigned promises to pay with interest at 8.00 % per annum until paid, and that the

same shall be payable One Hundred Fifty Eight and -----25/100 Dollars (\$ 158.25)

per month beginning on the first day of February 19 92 to be applied first to interest,

and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.
