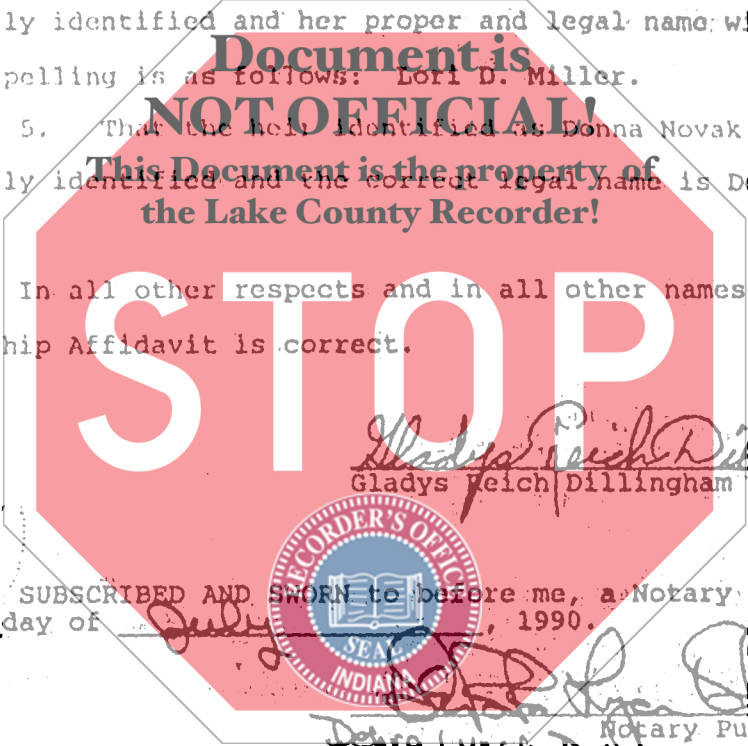

3. That the heir identified as Terri Novak Hynke should have been identified as and the correct spelling of her name is as follows: Terri L. Hynek.

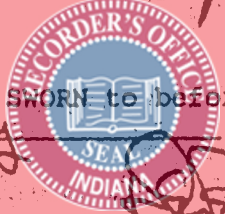
4. That the heir known as Laurie Novak Miller was incorrectly identified and her proper and legal name with the correct spelling is as follows: Lori D. Miller.

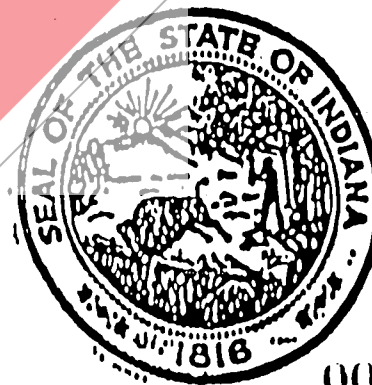
