## 7: BORROWER'S FAILURE TO PAY AS REQUIRED

(A) Late Charge for Overdue Payments

If the Note Holder has not received the full amount of any blweekly or monthly payment by the end of seven calendar days after the date it is due, I will pay a late charge to the Note Holder. The amount of the Charge will be 5,0000 % of my overdue payment of principal and interest: I will pay this late charge promptly but only once on each late payment.
