The Mortgager and Mortgagee hereby acknowledge and agree that the proceeds of the loan secured by this Mortgage are being used solely for the purpose of Mortgager equiring legal title to the property encumbered by this Mortgage by deed of even date herewith executed as part of this transaction. Further, Mortgager and Mortgagee acknowledge and agree that this Mortgage shall be a purchase money mortgage with the priority established by Indiana Code Section 32-8-11-4.

This Mortgage is given to secure the performance of the provisions hereof and the payment of a certain promissory note ("Note") dated <u>January 1, 1992</u>, in the principal amount of Ten thousand dollars (\$10,000.00) with interest as therein provided and with a final maturity date of <u>July 1, 1997</u>.

Said: principal and interest are payable as follows:

Three hundred and fifteen dollars (\$315.00) to be paid on the first day of August 1992. Thereafter payment of principal and interest is to be made in fifty nine (59) monthly installments of fifty two dollars and fifty cents (\$52.50), the first installment beginning the first day of September 1992, and payable upon the first day of each month thereafter until and including the first day of July 1997. The balance of principal and interest then remaining unpaid in the amount of six thousand five hundred eighty seven dollars and fifty cents (\$6,587.50) chall be due and payable on the very same the Lake County Recorder!

The Mortgagor (ijointly and severally) covenants and agrees with the Mortgagee that:

- 1. Mortgagor's Representation of Fee Simple Ownership. Mortgagor represents and warrants to Mortgagee; that he owns the fee simple title to said property subject only to specified encumbrances and encumbrances of record and has full right to mortgage said property.
- 2. Payment of Indebtness. The Mortgager shall pay when due all indebtness secured by this mortgage, on the dates and in the amounts, respectively, as provided in the Notesor in this Mortgage, without relief from valuation and appraisement laws, and with attorney's fees.
- 3. No Liens. The Mortgagor shall not permit any lien of mechanics or materialmen to attach to and remain on the Mortgaged Premises or any part thereof for more than 45 days after receiving notice thereof from the Mortgagee.

- 4. Repair of Mortgaged Premises; Insurance. The Mortgagor shall keep the Mortgaged Premises in good repair and shall not commit waste thereon. The Mortgagor shall produce and maintain in effect at all times adequate insurance in insurance companies acceptable to the Mortgagee against loss, damage to, or destruction of the Mortgaged Premises because of fire, windstorm, or other such hazards in such amounts as the Mortgagee may reasonably require from time to time, and all such insurance policies shall contain proper clauses making all proceeds of each policies payable to the Mortgagee and the Mortgagee until the indebthess secured hereby is fully paid.
- 5. Condemnation Proceeds. The Mortgagee shall have the right to have all condemnation proceeds received by Mortgagor as a result of any condemnation of the property acroided toward reduction of the Mortgage and Note.
- 6. Taxes and Assessments. The Mortgagor shall pay all taxes or assessments levied or assessed against the Mortgaged Premises, or any part thereof, as and when the same become due and before penalties accrue.
- 7. Advancements to Protect Security. The Mortgagee may, at his option, advance and pay all sums necessary to protect and preserve the security intended to be given by this Mortgage. All sums so advanced and paid by the Mortgagee shall become a part of the indebtness secured hereby and shall bear interest from the date or dates of payment at the rate of twelve per centum (12%) per annum.

Such sums may include, but are not limited to, insurance premiums, taxes, assessments and liens which may be or become prior and senior to this Mortgage as a lien on the Mortgaged Premises, or any part thereof, and all costs, expenses and attorney's fees incurred by the Mortgagee in respect of any and all legal or equitable proceedings which relate to this Mortgage or to the Mortgaged Premises.

- 9. Default by Mortgagor; Remedies of Mortgagee. Upon default by the Mortgagor in any payment provided for herein or in the Note, or in the performance of any covenant or agreement of the Mortgagor hereunder, or if the Mortgagor shall abandon the Mortgaged Premises, or if a trustee or receiver shall be appointed for the Mortgagor or for any part of the Mortgaged Premises, including a trustee or receiver appointed in any bankruptcy action, then and in any such event, the entire indestness secured hereby shall become immediately due and payable at the option of the Mortgagee, without notice, and this Mortgage may be foreclosed accordingly. Upon such foreclosure the Mortgagee may continue the abstract of title to the Mortgaged Premises, or obtain other appropriate title evidence, and add the cost thereof to the principal balance due. Additionally if the Mortgagor abandons the property after default the Mortgagee shall have the right to retake possession of the property.

- 10. Non-Walver; Remedies Cumulative. No delay by the Mortgagee in the exercise of any of his rights hereunder shall preclude the exercise thereof so long as the Mortgagor is in default hereunder and no failure of the Mortgagee to exercise any of his rights hereunder shall preclude the exercise thereof in the event of a subsequent default by the Mortgagor hereunder. The Mortgagee may enforce any one or more of his rights or remedies hereunder successively or concurrent occurrent.
