**REAL ESTATE POWER OF ATTORNEY**

KNOW ALL MEN BY THESE PRESENTS: That I, John Paul Haak, do hereby make, constitute and appoint Steve Hutka my true and lawful attorney for me and in my name, place and stead, giving and granting unto my said attorney full power and authority pursuant to Indiana Code 30-5-5-2(A) to do and perform all acts required to sell and convey my interest in the following described real estate in Lake County, Indiana:

All acts done by my attorney in fact or agent pursuant to the attorney in fact's instructions during any period of disability or incompetence or uncertainty as to whether I am dead or alive shall have the same effect and shall bind my heirs, legatees, devisees and personal representatives as if I were alive, competent and not disabled.

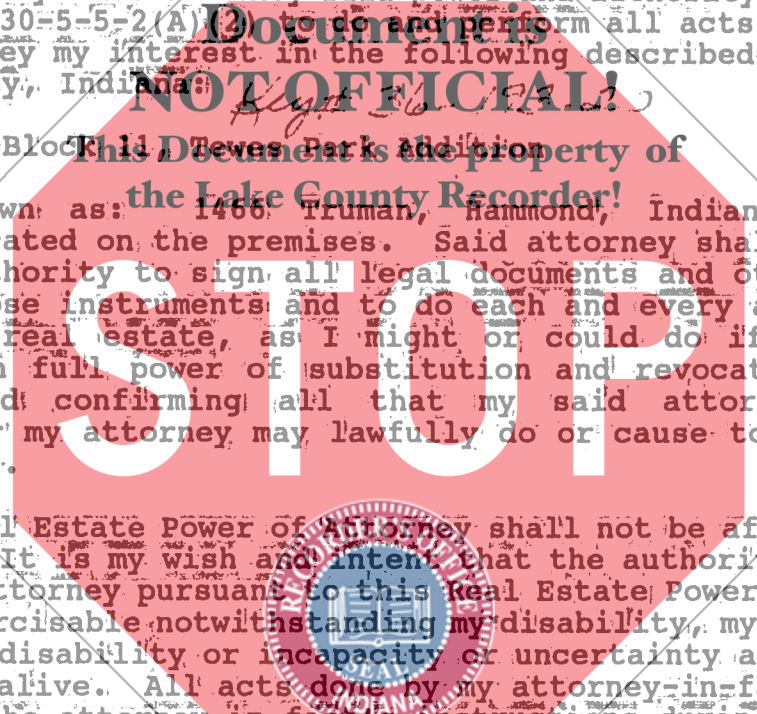
