## EASEMENT

WHEREAS, Grantee desires an easement for access across Granton's parcel to allow for maintenance upon the Westerly portion of said building.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties agree as follows:

1. That the Grantor does hereby grant to the Centier Bank, formerly known as First National Bank of Crown Point, as Trustee under Trust No. 53-0148, and Jack L. Sweikert and Bernadire B. Sweikert, husband and wife, an easement for access over and upon the following described parcel:

The East 10 feet of Lot 33 in Belshaw in Plat Book 11, page 20, in the Office of the Record of County, Indiana.

Said easement for access to allow Grantee to perform maintenance and/or repair of the Westerly position of the two-story brick and frame structure now logated on Lot Α.

- 2. The Grantors reserve the use of said strip of land for all purposes not inconsistent with the easement granted herein.
- 3. The Grantee covenants and agrees that subsequent to any repairs and/or maintenance that requires the use of said easement, they shall leave said strip in a clean and sightly condition and shall return said strip of land to the condition that existed prior to said repairs and/or maintenance.
- 4. The Grantee shall and will indemnify and hold the Grantors harmless from and against any and all damage, injuries, losses, claims, or demands caused by fault or negligence of the Grantee in the use of easement.
- The grant of this easement shall run solely for the benefit of the Grantee.
