LEGAL DESCRIPTION

PARCEL I: That part of the Southwest Quarter of the Southwest Quarter of Section 21, Township 34 North, Range 9 West of the Second Principal Meridian, described as follows: Beginning at a point on the South line of said Southwest Quarter, 923.90 feet (measured along the South line of said Southwest Quarter) East of the Southwest corner of said Southwest Quarter; thence North at an interior angle of 89 degrees, 45 minutes, 570 feet to the Southwest corner of Lot 37 in Vanco's Second Addition to Lake County, Indiana, recorded in Plat Book 33, page 6; thence East along the South line of said Lot 37, and said Lot 37 extended East, 293.65 feet to the West line of Vanco Drive, as shown in the plat of Vanco's Addition, recorded in Plat Book 30, page 64, thence South along the West line of said Vanco Drive, 420 feet, more or less, to a point 150 feet North (measured along the West line of said Vanco Drive) of the South line of said Southwest Quarter, thence West 100 feet along a line parallel to the South line of said Southwest Quarter, thence South along a line 100 feet West of and parallel to the West line of said Vanco Drive, 150 feet to the South line of said Southwest Quarter, thence West along the South line of said Southwest Quarter, 193.65 feet, more or less, to the point of beginning, in Lake County, Indiana.

PARCEL II: Part of the Southwest Quarter of Section 21, Township 34 North, Range 9 West of the Second Principal Meridian, bounded as follows: Commencing at a point on the South line of said section, which point is 530.78 feet West of the West right of way of the Chicago, Indiana and Southern Railroad Company and running thence North 150 feet, thence West 100 feet, thence South 150 feet to the South line of said section, thence East on the South line of the place of beginning.
