of 1933 ("HOLA"), 12 U.S.C. Sections 1464(D)(6)(A) and 1464(D)(6)(B), and 12 U.S.C. Section 1701c(c)(2)
(1982), as amended by P. L. 98-479, 98 Stat. 228 (1984); and

WHEREAS, effective August 9, 1989, the Resolution Trust Corporation ("RTC") succeeded the FSLIC as
Conservator of Seller pursuant to Section 501 of the Financial Institutions Reform, Recovery, and
Enforcement Act of 1989 ("FIRREA"); and

WHEREAS, effective May 25, 1990, the Office of Thrift Supervision ("OTS") replaced the Conservator
of Seller with the RTC as Receiver of Seller by OTS Order No. 931, dated May 25, 1990, pursuant
to Section 5(d)(2)(H)(ii) of the HOLA, as amended by Section 301 of FIRREA.

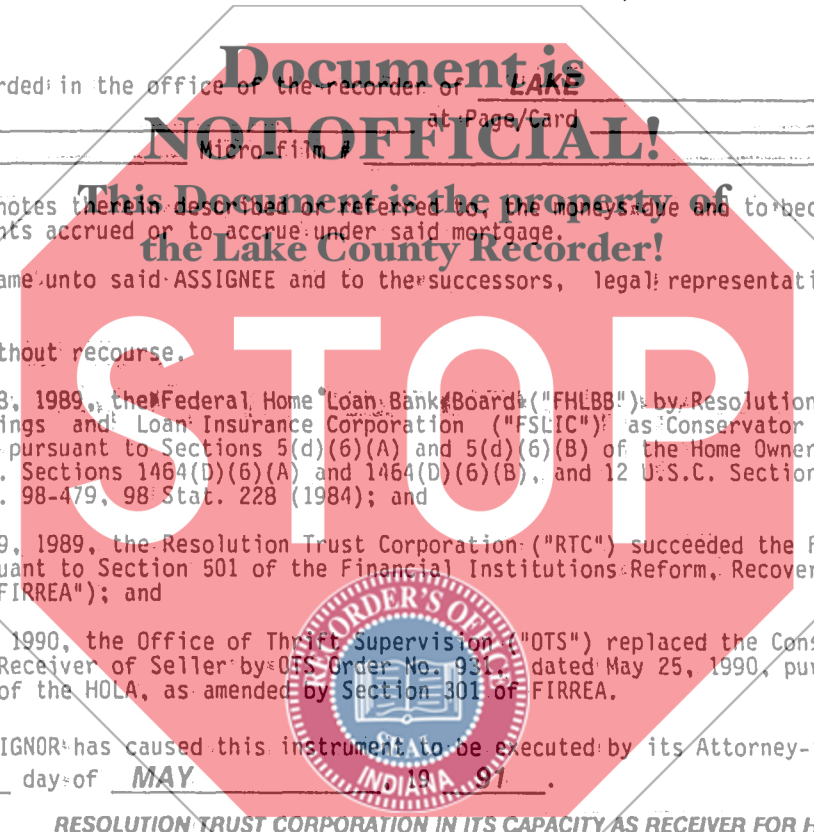
