for the City of Lowell, State of Indiana, aforesaid; (County: City-Township-District)

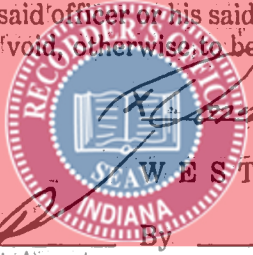
for the term beginning from the 5th day of February, 1992, to the 5th day of February, 1993, and until his successor is duly qualified.
