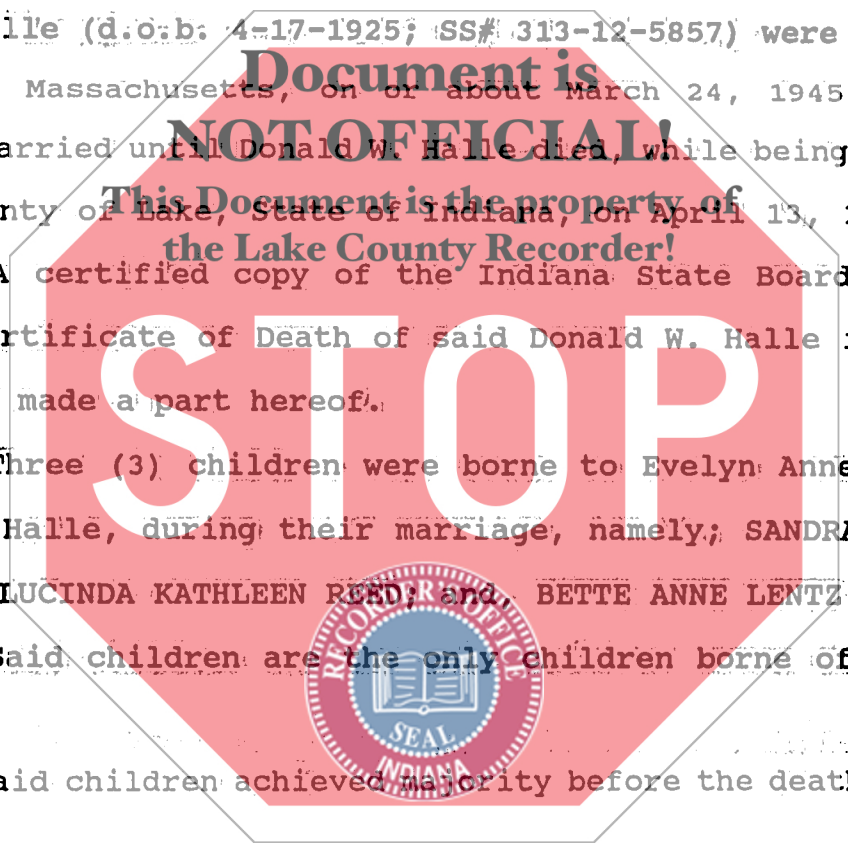
4. Said children are the only children borne of Donald W. Halle.

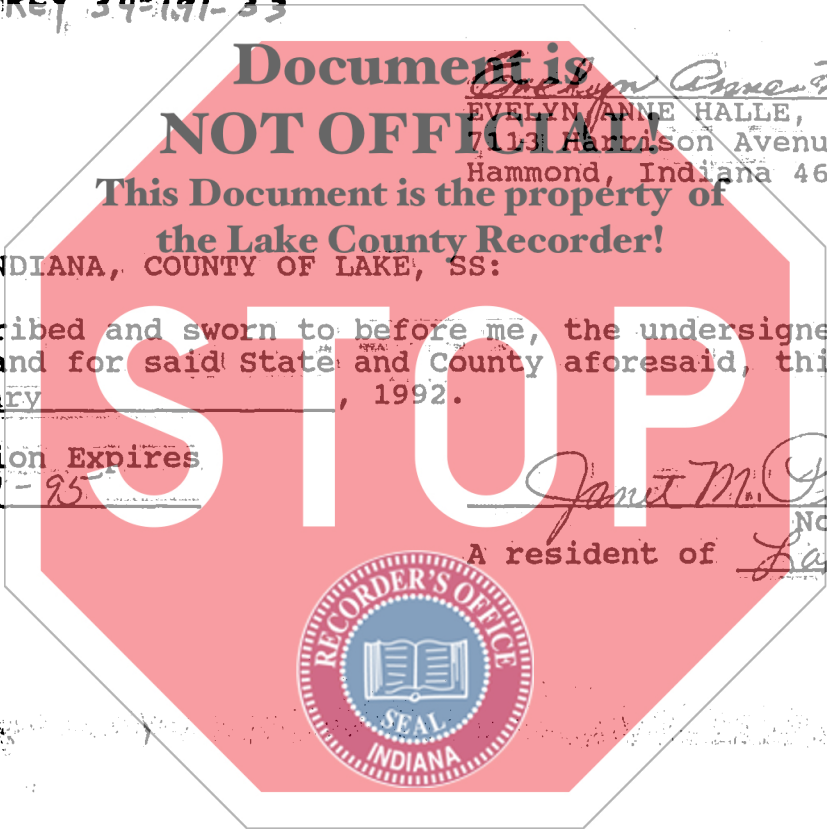
