- 1. For mutual consideration, the receipt of which is hereby acknowledged, the Lender and Borrower are both desirous of and agree to modify the terms of said Note and Mortgage as follows:

- The Borrower promises and agrees to pay to the order of Lender the sum of \$113,887.89 payable in monthly installments of \$1,088.28, with interest at 8.00% per annum, including principal and interest, from 2/1/92 commencing on the 1st day of March, 1992, and a like sum on the 1st day of each and every month thereafter, until the principal and interest are paid in full except that the final payment of the entire indebtedness evidenced hereby shall be due and payable on the 1st day of February 2007 if not sooner paid, all without relief from valuation and appraisement laws and with attorney fees in the event of default. the Lake County Recorder!
- B. In addition to the installments of principal and interest as set out heretofore, Borrower hereby reaffirms and agrees to abide by all of the terms, conditions and covenants contained in the aforesaid Real Estate Mortgage and Note as modified herein.
- C. Borrower specifically agrees, presents and acknowledges that proper legal and adequate consideration is being given them to enter into this Agreement and that Borrower is and continues to be legally bound and obligated for, by and under said indebtedness.
- D. The Borrower further agrees that all terms, conditions and covenants of the aforesaid indebtedness shall remain thaltered and in full force and effect except as herein expressly modified.
