AND, WHEREAS, it appears that JAMES C. PATTON did thereupon pay the amount of his bid to the County Treasurer of said county in cash.

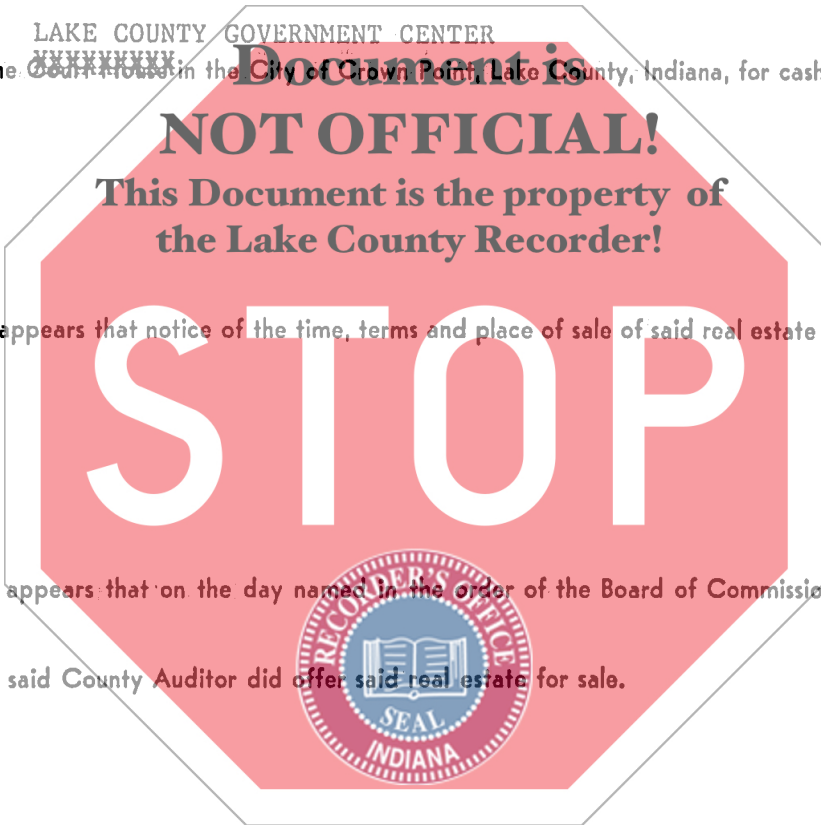
AND, WHEREAS, the County Auditor did on the 18TH day of FEBRUARY, 1992 report his proceedings therein to the Board of Commissioners.




