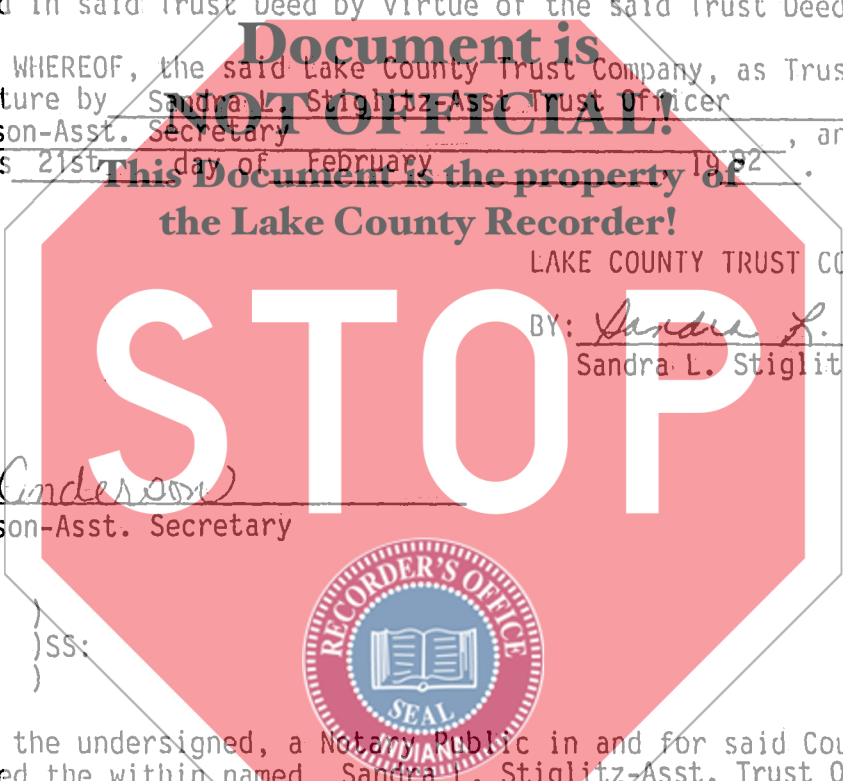
THIS INDENTURE, made this 21st day of February, 19 92,
