This indenture witnesseth that WALTER N. BARGERON AND JEAN L. BARGERON, Husband and Wife, being over the age of eighteen (18) years,

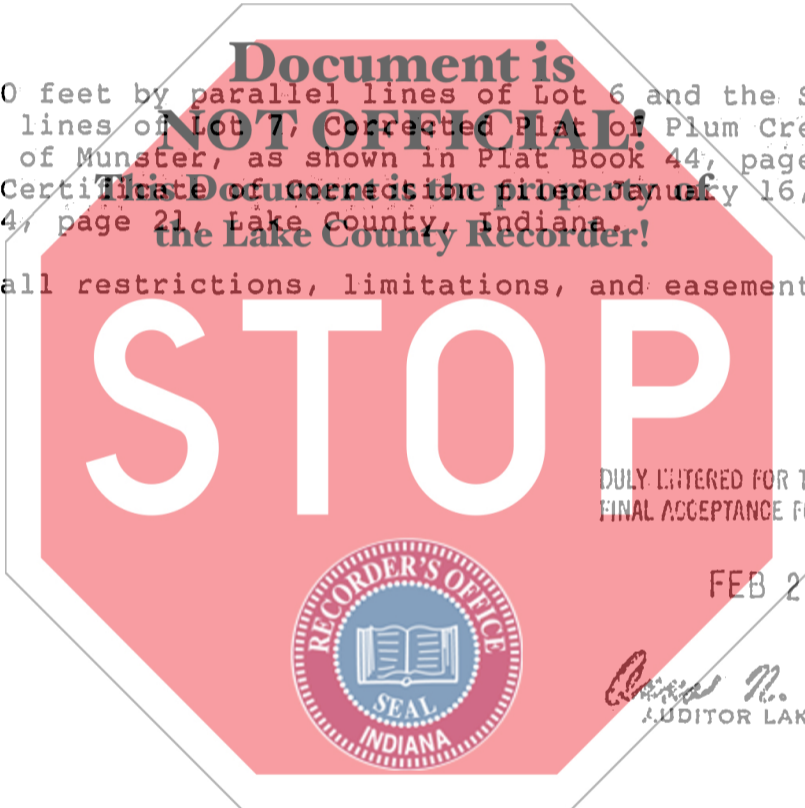
