Addendum A

Part of the East 1/2 of the Southeast 1/4 of Section 24, Township 35 North, Range 9 West of the 2nd Principal Meridian, in the Town of Schererville, Lake County, Indiana, being more particularly described as follows: Commencing at the Southwest corner of said East 1/2; thence North 00 degrees 17 minutes 26 seconds East along the West line of said East 1/2 a distance of 1693.10 feet; thence South 89 degrees 42 minutes 34 seconds East, 3.37 feet; thence North 00 degrees 17 minutes 26 seconds East, 205.00 feet; thence North 73 degrees 35 minutes 00 seconds East, 314.00 feet; thence North 12 degrees 50 minutes 00 seconds East, 97.00 feet; thence North 84 degrees 05 minutes 00 seconds East 154.00 feet; thence South 34 degrees 00 minutes 00 seconds East, 141.00 feet to the true place of beginning of the tract herein described; thence North 26 degrees 10 minutes 00 seconds East, 74.00 feet, thence South 76 degrees 36 minutes 30 seconds East, 123.07 feet, thence Southwesterly along a circular curve which is convex to the Northwest whose radius equals 224.40 feet, tangent equals 9.91 feet, deflection angle equals 05 degrees 03 minutes 30 seconds, a distance of 19.81 feet along said curve; thence Southwesterly along a circular curve which is convex to the Southeast whose radius equals 247.44 feet, tangent equals 46.13 feet, deflection angle equals 21 degrees 07 minutes 12 seconds, a distance of 91.21 feet, thence North 60 degrees 32 minutes 48 seconds West, 136.96 feet to the place of beginning.
