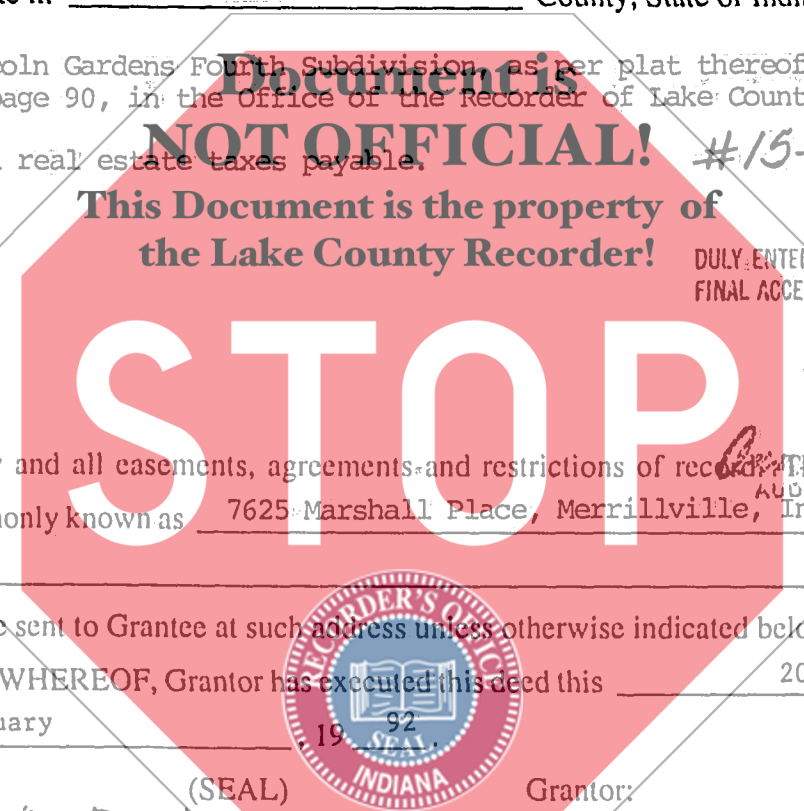

Subject to all real estate taxes payable.



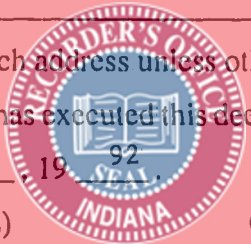
