WHEREAS, the note secured by the Mortgage Gainer Bank for collection, pledgee or in trust for any person, firm or corporation; and

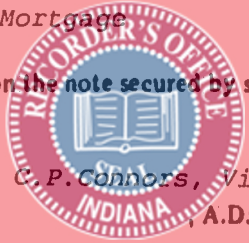
