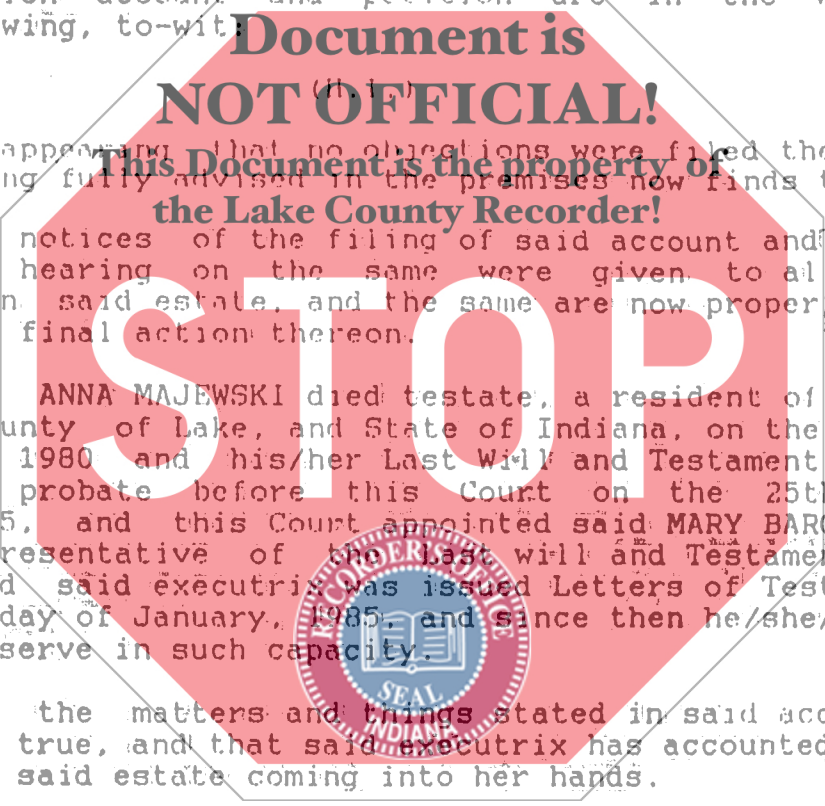

This cause came to be heard on the 31st day of October, 1991, upon the final account, petition to settle and allow account, and for authority to distribute estate filed by MARY BAROEVICH, as executrix of the estate of ANNA MAJEWSKI, deceased, which account and petition are in the words and figures following, to-wit:



And it appears that no objections were filed thereto the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That ANNA MAJEWSKI died testate, a resident of the City of Gary, County of Lake, and State of Indiana, on the 24th day of January, 1980 and his/her Last Will and Testament was duly admitted to probate before this Court on the 25th day of January, 1985, and this Court appointed said MARY BAROEVICH as personal representative of the Last will and Testament of the decedent, and said executrix was issued Letters of Testamentary on the 25th day of January, 1985, and since then he/she/they has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. JOHN MAJEWSKI is the sole legatee and devisee under the decedent's Last will and testament. Distribution should be made to the estate of the above-named party, now deceased.

6. The decedent owned a parcel of real estate at her death, particularly described as follows: **KEY 46-125-15**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final report and Account of said executrix is hereby in all things approved, settled and confirmed.

2. The distribution of the balance of the property remaining in executrix's hands for distribution should be made pursuant to distribution set forth in the final accounting, as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

And that said executrix is hereby directed to procure and record in the office of the recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

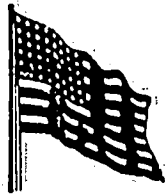
