- 12 Payments. Lagree to make all payments on the secured debt when due. Unless we agree otherwise, any payments you receive from me or for my benefit will be applied first to any amounts Lowe you on the secured debt exclusive of interest or principal, second, to interest and then to principal. - 2. Claims against*Title. I will pay all taxes, assessments, hens, encumbrances, lease payments, ground rents, and other charges relating to the property when due. You may require me to provide to you copies of all notices that such amounts are due and the receipts evidencing my payments.
