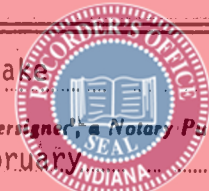

Parcel I

Part of lots 4, 5 and 6 in Block "E" in Crumpacker Lake View Addition, in the City of Gary, as per plat thereof, recorded in Plat Book 15 page 27, in the Office of the Recorder of Lake County, Indiana, said part of said Lots being described as follows: Beginning at a point on the Westerly line of Lots 4, 5 and 6 and 65 feet South of the Northwest corner of said Lot 6 (Said Northwest corner being the point of intersection of the Southerly line of Ironwood Avenue and the Easterly line of the Miami Street); thence Southerly along the Westerly line of lots 6, 5 and 4 a distance of 130.53 feet to a point 60.23 feet Northerly of the Southwest corner of said lot 4 (60 feet at right angles); thence Southeasterly a distance of 175.22 feet to a point on the East line of said lot 4 and 60.48 feet North of the Southeast corner of said lot 4 (60 feet at right angles); thence North along the East line of lots 4 and 5 a distance of 99.79 feet to a point 48.6 feet South of the Northeast corner of said lot 5; thence Northwesterly a distance of 198.8 feet to the point of beginning.

Parcel II

Part of Lots 5 and 6 in Block "E" in Crumpacker Lake View Addition, in the City of Gary, as per plat thereof, recorded in Plat Book 15 page 27, in the Office of the Recorder of Lake County, Indiana, described as follows: beginning at a point on the Easterly line of lot 5 and 48.6 feet South of the Northeast corner of said Lots 5; thence North along the East line of lots 5 and 6 a distance of 70 feet; thence Northwesterly along the Northeasterly line of lot 6 a distance of 35 feet; thence Southwesterly with an interior angle of 106 degrees 13 minutes a distance of 132.23 feet, more or less, to a point 51.0 feet Southeasterly of and on a straight line between a point on the Westerly line of lot 5 and 40.76 feet Northerly of the Southwest corner thereof and the point of beginning; thence Southeasterly 147.8 feet to the point of beginning.
