AMENDMENT TO CONTRACT FOR CONDITIONAL SALE OF REAL ESTATE

It is hereby agreed between BANK ONE, MERRILLVILLE, NA formerly known as BANK OF INDIANA, NATIONAL ASSOCIATION, as Contract Seller, and JILL K. ACKENHUSEN, as Contract Buyer, that the terms of a certain Contract for Conditional Sale of Real Estate dated January 20, 1984 and recorded January 24, 1984 as Document No. 742401, in the Recorder's Office of Lake County, Indiana, is hereby amended so as:

The current principal balance of said contract in the amount of \$14,126.59 will be due and payable as follows:

Principal and interest is due and payable in 11 installments of \$250.00 commencing on February 16, 1992 and on the same date of every one month thereafter until January 16, 1993, at which time the entire remaining unpaid principal balance and all accrued interest is due and payable in full.

The final payment is a balloon payment.

The Rate of Interest is fixed at 12.0% per annum until the Contract is paid in full.

It is further agreed that all terms and conditions of the aforementioned Contract and all other instruments signed in connection with that Sale, except as herein specifically amended, shall remain unchanged and are hereby ratified, as to the following legally described property located in Lake County, Indiana:

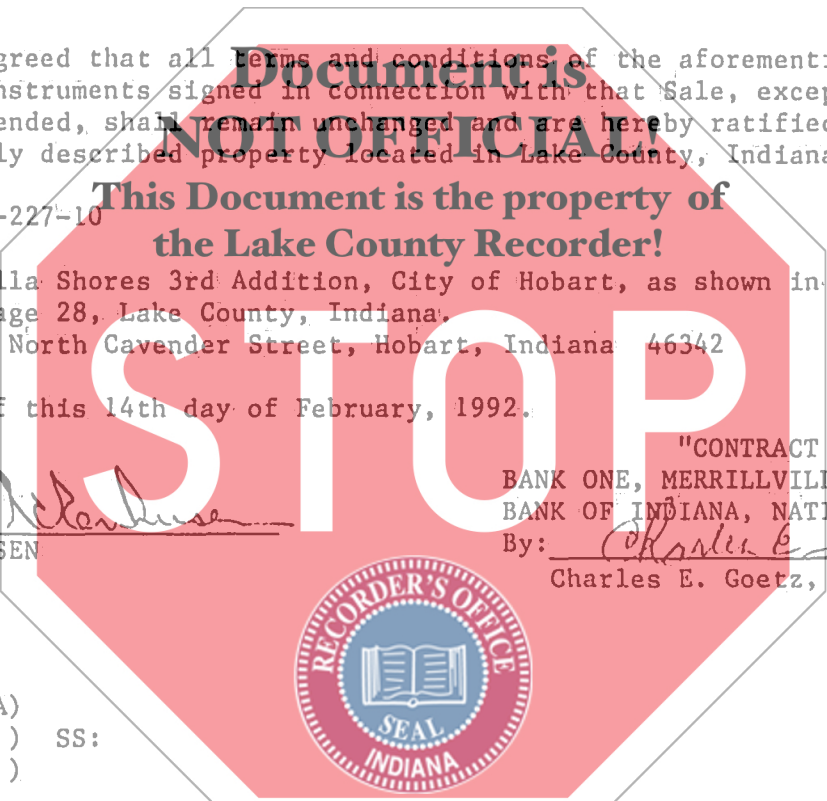
