MODIFICATION AGREEMENT

- The parties hereby modify the terms of said Note and said Mortgage, 2. as follows:

The interest rate shall be reduced to 7.25% effective April 1. <u> 1992 ...</u>.

The monthly principal and interest payment amount shall be adjusted to \$ 366.56 beginning May 1, 1992.

The next interest rate change date shall be April 1, 1995 and the payment shall change May 1, 1995

Borrower hereby agrees to pay the indeptedness evidenced by said Note and secured by said Mortgage and to comply with and perform each and every covenant, condition and obligation contained therein as so modified or in any instrument at any time given to evidence or secure said indebtedness, or any part thereof.

IT IS understood and agreed that all terms and conditions of the aforementioned promissory Note and Mortgage, including prior modifications thereof, if any, shall remain in full force and effect without change except as heretofore otherwise specifically provided.
