- 1. Payments of Principals and Interest. Borrower shall promptly pay when due the principals and interest indebtedness evidenced by the Note and late charges as provided in the Note.

Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy.
